### **GOLF CLUB SAFEGUARDING AND CHILD PROTECTION POLICY**

Best Western Plus Magnolia Park Hotel, Golf & Country Club has considered its responsibilities to the children participating in golf at our premises and within our club very carefully, and has produced the following Safeguarding and Child Protection Policy and underpinning procedures in order to set out the standards we wish to uphold in providing activities for children and safeguarding the welfare of children in our care.

### **POLICY STATEMENT**

Best Western Plus Magnolia Park Hotel, Golf & Country Club acknowledges its duty of care to safeguard the welfare of all children (defined as those under 18) involved in golf within the club. All children have a right to protection, and have their particular needs taken into account.

It is the responsibility of all adults within the club to assist the Management Committee in this endeavour.

### **POLICY AIMS**

- To provide children with appropriate safety and protection whilst in the care of the club and also help them to enjoy their experience of the sport
- To reassure parents that their children will receive the best practicable care possible whilst participating in activities within the club
- To provide support to staff and volunteers to make informed and confident responses to specific child protection issues and to fulfil their role effectively

## PRINCIPLES

- The welfare of children is paramount
- All children, whatever their age, culture, disability, gender, language, ethnic origin and religious beliefs have the right to protection from abuse
- All suspicions and allegations of abuse and poor practice will be taken seriously and responded to swiftly and appropriately
- All staff and volunteers working in golf have a responsibility to report concerns to the Club Welfare Officer
- Adults – staff, volunteers, coaches, referees and members will be supported to understand their role and responsibility with regard to the duty of care and protection of children and young people
- Individuals will receive support through education and training to be aware of and understand best practice and how to manage any welfare or child protection issues that may come to light

Best Western Plus Magnolia Park Hotel, Golf & Country Club will work in partnership with parents to review and implement child protection and welfare procedures Best Western Plus Magnolia Park Hotel, Golf & Country Club's policy and procedures are based on the above principles and UK and international legislation and government guidance and take the following into consideration:

## RESPONSIBILITIES & COMMUNICATION

- The Best Western Plus Magnolia Park Hotel, Golf & Country Club Safeguarding and Child Protection Policy will be available to all members, parents, staff, volunteers and participants
- The Policy will be reviewed every three years by the Directors, and amended as appropriate. Guidance from golf's governing bodies will be sought as part of the review process
- The Directors have responsibility for ensuring that the policy and procedures are implemented, including taking any appropriate disciplinary action necessary
- The Director of Golf has responsibility for responding to any allegations, concerns or child protection incidents, passing information to the appropriate National Governing Body Lead Child Protection Officer and informing the appropriate club staff
- Parents have a responsibility to work together with the club in implementing procedures and providing their children with the necessary information to safeguard themselves
